TERMS AND CONDITIONS

- Sampson Ranch** hereby reserves for the Mare Owner one breeding to the Azuul during the 2026 Breeding Season. This reservation has been secured with a Mare Owner's Booking Fee of \$500, which is non refundable and will be applied to the Stallion Service Fee and included with this contract. If more than one pregnancy is desired from this Stallion (embryo transfer or ICSI,) then a contract and service fee will be required for each breeding.
- Mare Owner** The mare owner represents the Mare is healthy and in sound breeding condition. The Mare Owner agrees to attach a copy of the Mare's registration papers with this document and agrees to furnish any other information upon reasonable request. Mare Owner agrees to use all semen provided by this Contract for ONLY the Mare named in this Contract. Please provide in-foal confirmation to CSU- Reproduction Center (970-491-8626) within 60 days. If the Mare dies or is deemed unfit during the breeding season, a substitute Mare, approved by Sampson Ranch, may be bred without any additional contract fees.
- Charges** The Mare Owner and/or any individuals executing this Agreement shall agree to pay the following:
 - **Booking Fee** (due with the signing of this contract): \$ 500
 - **Balance of Stallion Service Fee**
- Shipped Semen or Onsite Breeding Fees** Please mark the box for your selection:

Shipped Semen

All payments for Stallion Service and shipped semen must be paid in full prior to shipment. Collection days are Monday, Wednesday, Friday. Semen must be requested by 4:00 pm MST the day prior to the necessary collection day and canceled/confirmed by 9:00 am MST the day of collection. Contact CSU- Equine Reproduction Center (970-491-8626) If cooled semen is unavailable, frozen semen (2 doses) will be used to cover breeding of the mare.

Onsite Breeding

All Booking and Stallion Service Fees must be paid in full prior to collection for on farm breeding.

Every attempt will be taken to deliver cooled/frozen semen to mare owner in good condition, however once the shipment leaves CSU ERC, Sampson Ranch and/or CSU ERC cannot be held responsible for delayed arrival or condition of semen upon arrival.

5. **Live Foal Guarantee** This contract between the Mare Owner and Sampson Ranch for the above named mare is non-transferable and provides one return breeding, in succeeding year only, for the Mare (or agreed upon substitute) that fails to produce a live foal. A live foal is a newborn foal that stands and nurses without assistance. Rebreed services will be provided under the following conditions:
 - a. Mare owner provided CSU-ERC with written confirmation from a licensed veterinarian of ultrasound results confirming pregnancy within 60 days.
 - b. In the case of a miscarriage, stillborn foal, or death of mare after having been pronounced in foal, Mare Owner will provide CSU-ERC with written confirmation from veterinarian within 30 days regarding loss of pregnancy/failure to stand and nurse/or cause of death.
 - c. Rebreed services will require \$500 rebreed fee.
 - d. Rebreed is valid for the following year only. If Mare Owner fails to rebreed the following year, then any and all fees will be forfeited. The rebreed option will be null and void after the following season. Sampson Ranch and CSU-ERC are released from all obligations of this contract, unless otherwise agreed upon in writing.

6. **Breeders Certificate** A Breeders Certificate shall be issued when all fees have been paid in full.

7. **General** It is further agreed upon that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, that the breeding fee will transfer to frozen semen only and for the year of this contract only.

8. **Other Provisions** This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in the written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.
